Please accept this letter as a please to urge the Supreme Court to accept review of Mr. Charles Benninghoff's case referenced above.

I am a citizen interested in this case because it is an example of a citizen using his or her education, talents and God given intelligence to assist others. Even at 83 years of age, I can understand Legislative Counsel Opinion #18108. It states quite clearly and specifically that a "resigned attorney may provide representation in an administrative hearing on the same basis as any other nonattorney". I believe that Mr. Benninghoff was representing people before California agencies with this, it seems to me, very clear authorization.

If Mr. Benninghoff is not now going to be allowed to do agency work as a resigned attorney, and as the Legislative Counsel so wrote, then it seems to me up to the Legislature alone to write the laws accordingly. I always understood the writing of law to rest with the legislature, not the courts.

We, the public, are concerned because what happens to our State Constitution and system of law if our courts continue to rewrite law at will, and in this case for no apparent good or purpose?
