Dear Chief Justice George and Honorable Associates Justices

I submit this letter to urge the Supreme Court to accept review of Mr Benninghoffs plea for help.

I am an Australian citizen who has visited the US and still have strong ties with your country. I follow with interest the daily goings on in the US and of late have become quite concerned with a lot of what happens, especially in courts. I am writing in the hope that Your Honors will do justice in Mr Benninghoff's case and not create a judicial crime after the fact.

I have been informed that Mr Benninghoff was representing people before California agencies after having received Legislative Counsel Opinion #18108 that specifically stated he could do so. Yet it seems the court seeks to overturn this.

The writing of law rests with the Legislature, not the courts. Therefore if Mr Benninghoff is prevented from doing agency work as a resigned attorney, and as the Legislative Counsel wrote, then it is up to the Legislature to write the laws accordingly

I am very concerned about this business, especially after reading a US school book some years ago that stated that laws are made by judges. What has happened to a man's common law right to be represented by anyone he chooses ? If the courts take over the function of writing the law, the State and Federal Constitutions become null and void

This is of great public interest in many parts of the world and Mr Benninghoff has my support and that of many other Australians. We would like to know the US to be a country where everyone can have a fair go. One where we can visit friends and relatives and know that at all times we are safe and that the laws do protect all in the borders of the US.
