Dear Chief Justice George and Honorable Associates Justices:

I urge you and the Supreme Court to accept review of Mr. Benninghoff's plea for help.

My interest is that I am a citizen of the United States hoping that Your Honors will do justice in Mr. Benninghoff's case and avoid committing judicial crime after the fact.

I was told, and ***do believe***. Legislative Counsel Opinion #18108 gave Mr. Benninghoff specific authorization to represent people before California agencies. **[I also]** was told through recitation of facts, and ***do believe***, that Mr. Benninghoff was dragged into this position of having to appeal to you because of twisted thinking and egregious, immoral and illegal behavior on the part of irresponsible (read: arrogant) State bureaucrats in concert with The California Bar – but discussion of this matter is beyond the scope of this request.]

Writing of law rests with the Legislature, not the courts—any court. If Mr. Benninghoff is not to be allowed to do agency work as a resigned attorney in accordance with what the Legislative Counsel so wrote, then it is up to the Legislature to address the laws accordingly. A State Court has no business even dreaming of writing law, much less doing it!

This issue is of immense public interest across our great nation. Why? If State courts continue to rewrite law, then every State Constitution is rendered moot – irrelevant -- and we become/remain subject to the whims of men and not to the Rule of Law.
