I am writing this letter to be submitted and strongly urge the Supreme Court to accept review of Mr. Benninghoff's plea for help.


My interest in this case is that I am a single father, physician and law abiding American citizen hoping that Your Honors will do justice in Mr. Benninghoff's case and not create a judicial crime after the fact. I have personally been abused by political operatives, unaccountable to the word of law, who have utilized Bills of Attainders to harm those deemed undesirable by the "powers that be." I implore you to act in a moral and ethical fashion regarding Mr. Benninghoff's plea.

I was told, and do believe, that Mr. Benninghoff was representing people before California agencies after having received Legislative Counsel Opinion #18108 that specifically stated he could do so.

The writing of law rests with the Legislature, not the courts. Therefore, if Mr. Benninghoff is not to be allowed to do agency work and strive for justice as a resigned attorney as the Legislative Counsel so wrote, then it is up to the Legislature to responsibly and in accordance with the Constitution write the law.
